

Cynthia Herbert-Bruschi Adams began her career in academia at the University of Connecticut where she is now a Professor Emerita and a retired psychologist. Her early writing was in journal articles, textbooks and trade books in health related areas.

In 2019 she published **Italian Spices:** A Memoir about the Italian side of her family. The Farmhouse on Cemetery Hill Road was her first novel. In the Spring of 2021 she published its sequel, The Portal and then completed the trilogy with AH, GRACE! She has just completed THE RED TOQUE: LOVE AND LOSS IN THE TIME OF TITO, based on actual people who experienced WWII in Eastern Europe. It tells the story of a family growing up in Slovenia through two world wars. There is heartbreak and loss, but eventually triumph as they come through the war. First He Killed the Minuteman is her first true crime book.


Jodi Walencewicz Northeastern CT

While I still serve on the Portland Communications Committee and publish the ALTRUSAGRAM, I have recently been assigned co-chair of the Membership Development Committee and ASTRA alongside Trish Maxim.

Conference Rules

- 1. All Altrusans must be properly registered. Only registered Altrusans will be admitted to Business Meeting and Workshops.
- 2. Voting body at district conference shall consists of the District Board of Directors, regularly accredited delegates of the Clubs within the District and all Past Governors holding active membership in their respective local Altrusa clubs who may be present.
- 3. A majority of the members who are entitled to vote shall constitute a quorum and the act of the majority of the members present at a meeting in which a quorum is present shall be the act of the members of the District. (District One By-Laws, Article VII).
- 4. Delegates shall wear the delegate's ribbon and in the General Business Meetings shall sit in the section reserved for voting members. Alternates may vote only in the absence of their Delegates and in this event must sit in the voting section.
- 5. Only members of the voting body may introduce motions and vote, but both voting and non-voting members are allowed the privilege of the floor. Precedence is accorded to Delegates.
- 6. Anyone wishing the floor for making motions or for discussion state name and name of local club or office in order to be recognized.
- 7. Discussion is limited to two minutes for each speaker. No one may speak twice on a subject until all who wish to speak have had the opportunity. The maker of the motion shall have the privilege of closing discussions.
- 8. All motions shall be written, signed and sent to the Chair upon request.
- 9. No motions shall be necessary to accept reports of Officers or Chairs except for the District Audit Report.
- 10. Advance Seating: Members shall be in their seats at least five minutes before the Business Meeting.
- 11. Communications: Only the Expediters shall deliver messages.
- 12. The conference rules shall be adopted or suspended by a majority vote or rescinded by a two-thirds vote of those present and voting, with a quorum being present.
- 13. Please turn all cell phones to silent mode.

Laconia, NH

Altrusa International of Laconia, NH continued their support for local nursing homes by providing cards to each resident during the holiday season. Members donated cards and members joined together to see that each resident received a beautiful card with a happy message letting them know they were being thought about at Christmas.

Central CT

Altrusa International of Central CT, Inc., initiated a new contact for our CLOSE (Children's Luggage Offers Self Esteem) program. Fostering Family HOPE (FFH) has ongoing needs for the luggage as foster children transition into and out of homes. FFH agrees that luggage and backpacks are a much better vessel for foster children's belongings. The children are already in distress and providing them with a suitcase provides some dignity and self-esteem. Meredith NH

Many clients are homeless and/or lacking funds to cover these personal care expenses. This project helps women in crisis, start their "new detoxed life", with basic personal care items.

2025 Letha H. Brown Literacy Project Submissions

Sanford-Springvale, ME

The Sanford-Springvale Altrusa Club is passionate about literacy, especially among the youth in our community. We wholeheartedly adopted this project because it not only achieved our desire of getting books into the hands of children, but it enabled us to connect with five other community-focused organizations.
